- 1. Waiting list deposit fee \$50.00.**
- 2. Administrative fee.** Once your name is assigned from the waiting list \$25.00 of the deposit will be applied to your account and \$25.00 will be retained by Swantown Marina as an administrative fee.
- 3. I realize my deposit is non-refundable,** but will be applied to my account once my name is assigned from the waiting list. I also understand that I am allowed three (3) turndowns. On the third turn down my \$50.00 will be forfeited, and my name will be removed from the waiting list.
- 4. I understand** that in order to secure a slip at the marina I must accurately provide my vessel's LOA. *It is recommended that you do not relinquish your moorage slip at your current moorage facility until your vessel LOA has been verified.*
- 5. I understand** that if I change my mailing address and/or phone number(s), I will notify the Harbor office in writing at 1022 Marine Drive NE, Olympia, WA 98501; Harbor office personnel are not obligated to locate my new address or telephone number(s).
- 6. Liveaboard application only:** all liveaboard vessels must have an approved Marine Sanitation Device (MSD). Port-a-potties are not allowed. A fixed approved MSD is required on all liveaboard vessels.
  - Verification of insurance is required to liveaboard i.e. boat owners insurance binder.
  - Additionally insure the Port of Olympia for \$300,000.00.
