### 2. Release of Legal Memorandum

Executive Director Sam Gibboney gave an overview of the Release of Legal Memorandum. ### 4. Small Cities Program

Danny Kim, GL Accountant, gave an overview of the Small Cities Program and how the program assisted the City of Yelm with their Sidewalk to Community Garden project.

## 5. Joint Base Lewis McChord Community Connector Program

Jennie Foglia Jones, Communications, Senior Manager Marketing & Government Affairs reported that Joint Base Lewis-McChord's 7<sup>th</sup> Infantry Division has requested that one Port of Olympia Commissioner serve as a regular representative for the 7ID Community Connector Program. Commissioner Bob Iyall volunteered to serve in that capacity.

#### 6. Commission Newsletter

Jennie Foglia Jones, Senior Manager Communications, Marketing & Government Affairs reported that a Commission Newsletter is being developed with Commissioner Amy Evans taking the lead on this project. This newsletter would be a direct line of communication from the Commission to the Port of Olympia staff members.

## 7. Multi-Purpose Training Center Commission Representative

Executive Director Sam Gibboney reported that the Commission authorized the executive of an Interlocal Agreement between the Port, the City of Olympia and LOTT Clean Water Alliance on February 28, 2022 regarding a collaborative effort to explore the feasibility of a Multi-Purpose Training Center.

The parties intend to conduct a joint scoping exercise to explore a possible collaborative project and define a pathway toward implementation. The scoping exercise will identify and prioritize goals for the project, considering opportunities for physical infrastructure as well as related training/programming.

Commissioner Downing agreed to serve as the Multi-Purpose Training Center Commission Representative.

Executive Director Gibboney reported on the recent revisions to the Open Public Meetings Act. She also introduced the Port of Olympia's new general counsel, Rick Hughes.
