## **POCAC-RENAMING WHITE PAPER REPORT**

#### Introduction

At the February 21, 2017, Special Joint Commission & Citizen Advisory Committee (POCAC) meeting, the Commission introduced five tasks for the POCAC.

The third task, **Port Name Change**, was introduced by Commissioner Bill McGregor. There is a concern the name, "Port of Olympia", does not fully represent the breath and scope of the activities of the Port and does not fully incorporate the support of citizens of Thurston County. The original statement of the POCAC's charge can be found on Attachment A.

The Port of Olympia Commissioners have specifically tasked the POCAC to: 1) review the options and process required to change a port district's name; 2) provide input on the process needed; 3) the timing for a process; and, 4) potential names. POCAC's results are provided below.

## **OPTIONS, PROCESS AND TIMING OF EACH:**

POCAC identified and evaluated 3 "options" and each associated process:

The first option identified, legally changing the corporate name of the port district. This is addressed in RCW (Revised Code of Washington) 53.04.110. In summary, it requires a petition be submitted to the Commissioners with signatures by at least 10% of the number of voters from the last general port election, asking the corporate name of the port district be changed. The Commissioners then submit the proposition at the next general port election, pursuant to RCW 29A.04.330 (Elections/ General Provisions/ City, town, and district general and special elections – Exceptions). Should a majority of the registered voters of the port district voting at the general port election vote in favor of the name change, the port district will change its name. The subject entire RCW is recited on Attachment B. The general timing for this would be approximately 6 months prior to a qualified election, and Commissioner action thereafter. Based on the costs of prior actions by the Port to take an issue to vote, estimated cost is \$95,000, per Port staff.

A second option, it was suggested to utilize a "trademark". This is regulated under RCW 19.77 (Business Regulations – Miscellaneous/ Trademark Registration). Although this is a simple process of proper registration with the Secretary of State, it is not typical as a business name, but as a symbol or design (see Port of Olympia logo) recognizing a business or product. Further opinion would require consultation with the Legal Counsel of the Port and is beyond the scope of this report. The timing necessary for this is that of administration.

Lastly is the option of a trade name, or, operating under a "DBA" (doing business as). This is a relatively simple process of filing an application with State of Washington Business Licensing Service with a minor filing fee of approximately \$24, and registering the DBA with the other appropriate state or federal agencies. This is an option employed by the Port of Skagit County, dba, Port of Skagit. Likewise, there are numerous examples of this practice by fire protection districts within the state of Washington. However, this option does not change the name of the Port of Olympia, but just creates another operating name for it. Additionally, any use of the DBA would require extensive name change to all instruments of the Port, e.g., letterhead, vehicles, business cards, logos, etc. Ballpark estimate on cost, per Port staff, of this "relabeling" is \$500,000 - \$750,000. This estimate includes changing all places where the existing logo and name shows. Other then as an accommodation, a DBA seemingly accomplishes little else. The timing necessary for this is that of administration, but could be estimated to be 6 – 9 months.

### **POTENTIAL NAMES:**

Although not an exhaustive list, based on the scope of this assignment, its intent, and the location of the Port, the following potential names are offered:

- 1. Port of Thurston County
- 2. Port of LOTT
- 3. Port of South Puget Sound
- 4. Port of Olympia and Thurston County
- 5. Thurston County Port of Olympia
- 6. Port of Olympia-Thurston County
- 7. Thurston County Port

### POCAC OPINION OF CHANGING THE NAME OF "PORT OF OLYMPIA":

POCAC has questioned the objective of changing the name of the Port of Olympia, and would a name change accomplish the objective. POCAC's understanding of the objective is, now that the Port has property ownership in multiple cities, including Olympia, Tumwater and Lacey, and has a Small Cities Program, and receives revenue from a tax imposed on all property owners in Thurston County, that a name change would provide greater service recognition and acceptance by taxpayers being subject to this tax. POCAC does not believe a name change would accomplish this and believes the Port is already providing greater effort, successfully, to foster Port identity and acceptance through multiple staff and internal processes, identified indepth in the "Port of Olympia Communications Plan" dated February 13, 2017. This Plan is comprehensive in that it introduces the Port, identifies both an Internal Communications component and an External Communications component, and cites its Social Media Program. POCAC supports and appreciates the efforts of Port staff in this approach and believes this will be more productive for the perceived objective than a name change.

# Renaming the Port of Olympia?

Background:				
The Port of Olympia has been in existence for 95 years. In early times, Ports were typically named after the city or county that was closest to their geographical location. Hence the Port of Olympia. While this port was established as a county wide port with its geographical boundaries those of the boundaries of Thurston County, it took on the Olympia.				
Overtime, the Port has worked to impact the entire county with holdings in Olympia (Swantown Marina, Port Real Estate Holdings, Marine Terminal). In Tumwater during the 1960's the Port took control of the Olympia Airport (located in the Tumwater City limits) and began development opportunities with the land that was included outside the Airport operational area. About 2010, the Port looked at opportunities to assist with economic development in the South County areas of Yelm, Tenino, Rainier and Bucoda via the Small Cities Program. Up until February of this year, the Ports only presence in Lacey was via the Foreign Trade Zone (used by Chehalis Mints). In February of this year, the Port will be closing on a property/building(s) purchase in Lacey's Gateway area. The result is the Port is developing and working on economic development opportunities in all corners of the county.				
It may be time to review the Ports identity to reflect our continued expansion of its impact in our county and change the name.				
While there is a public process to change the name of a port in RCW 53.04.110 (Change of Name). There is also a process via a Trademark option that does not require a formal name change via the election process. The Trademark option will require some input from Legal Counsel on the legal process involved with that option.

## **Attachment B**

RCW 53.04.110 Change of Name

Any port district now existing or which may hereafter be organized under the laws of the state of Washington is hereby authorized to change its corporate name under the following conditions and in the following manner:

- (1) On presentation of a petition to the commissioners of any port district now existing or which may hereafter be established under the laws of the state of Washington, signed by at least ten percent of the total number of voters of the port district who voted at the last general port election and asking that the corporate name of the port district be changed, it shall be the duty of the commissioners to submit to the voters of the port district the proposition as to whether the corporate name of the port shall be changed. The proposition shall be submitted at the next general port election according to RCW 29A.04.330.
- (2) The petition shall contain the present corporate name of the port district and the corporate name which is proposed to be given to the port district.
- (3) On submitting the proposition to the voters of the port district it shall be the duty of the port commissioners to cause to be printed on the official ballot used at the election the following proposition:

"Shall the corporate name, "	Port of	be changed to "Port of	"、	YES
"Shall the corporate name, "	Port of	be changed to "Port of	"	NO

- (4) At the time when the returns of the general election shall be canvassed by the commissioners of the port district, it shall be the duty of the commissioners to canvass the vote upon the proposition so submitted, recording in their record the result of the canvass.
- (5) Should a majority of the registered voters of the port district voting at the general port election vote in favor of the proposition it shall be the duty of the port commissioners to certify the fact to the auditor of the county in which the port district shall be situated and to the secretary of state of the state of Washington, under the seal of the port district. On and after the filing of the certificate with the county auditor as aforesaid and with the secretary of state of the state of Washington, the corporate name of the port district shall be changed, and thenceforth the port district shall be known and designated in accordance therewith.
