5-Member Commission Ballot Proposition

Rick Hughes, General Port Counsel, explained that the purpose of this Advisory item is for the Commission to consider a Resolution increasing the number of commissioners and to take public comment for possible adoption at the July 25, 2022 Commission Meeting. If adopted, the Resolution would place on the November 8, 2022 ballot, a proposition asking voters to increase the number of commissioners to five, with each commissioner serving in one of five newly drawn districts. In anticipation of the adoption of the Resolution on July 25, 2022, and pursuant to an Interlocal Agreement that the Port of Olympia has approved with Thurston County, the Committee will meet in the near future, to discuss cooperation on the joint redistricting process and the overall commission increase proposition.
